Main objective:

Ø Development of dynamic economy competitive on the European and international market

Specific objectives:


- Ø Encouragement of innovations and increasing the efficiency of enterprises
- Ø Improvement of business environment

Operational program "Competitiveness" Priority Axis and Financial Plan

- 1. Development of a knowledge-based economy and innovation activities (246 mln. euro, 21%)
- 2. Increasing efficiency of enterprises and promoting supportive business environment (593 mln. euro, 51%)
- Financial resources for developing enterprises (200 mln. euro, 17%)
- 4. Strengthening the international market positions of Bulgarian economy (87 mln. euro, 7.5%)
- 5. Technical assistance (34 mln.euro, 3%)

Total budget: 1 162 215 551 euro

Operational program "Competitiveness" Institutional framework



Priority Axis 1 – Development of a knowledgebased economy and innovation activities

<u>Area of Intervention 1</u> - Support for innovation activities in enterprises:

- Ø Support for creation and development of innovative start-up companies;
- **Ø** Support for creation and commercialization of innovations by enterprises;
- Support for increase of the share of R&D personnel in enterprises;
- Support for protection of the industrial property rights.

<u>Area of Intervention 2</u> – Improvement of pro-innovative infrastructure:

- Ø Creation of new and development of existing pro-innovative infrastructure;
- **Ø** Support for modernization of applied research equipment;
- Ø Creation of national innovation network.

Priority Axis 2 – Increasing efficiency of enterprises and promoting supportive business environment

<u>Area of Intervention 1</u> – Improvement of technologies and management in enterprises:

- Ø Upgrade of technologies in enterprises;
- Ø Achieving compliance with internationally recognized standards.

<u>Area of Intervention 2</u> – Creation of business support infrastructure:

- Ø Creation of Business Support Organizations (BSOs) network;
- Ø Creation of regional business incubators.

<u>Area of Intervention 3</u> – Introduction of energy-saving technologies and renewable energy sources:

- Ø Introducing energy-saving sources in enterprises;
- Ø Introduction of renewable energy sources satisfying the needs of the enterprise (RES).

<u>Area of Intervention 4</u> – Promotion of business networking and clustering:

Ø Promotion of business networking and clustering.

Priority Axis 3 – Financial Resources for developing enterprises (FREDE)

<u>Area of Intervention 1</u> – Improvement of access to finance for SMEs through instruments of financial engineering:

- Ø Support for guarantee funds;
- Ø Support for micro-loan funds;
- Ø Support for seed & venture capital funds investing in SMEs.

Priority Axis 4 – Strengthening the international market positions of Bulgarian economy

<u>Area of Intervention 1</u> – Promoting the investors' advantages of Bulgaria:

- Ø Providing analytical information of the investment trends in Bulgaria and abroad;
- Ø Pilot marketing campaigns for attracting investors in target sectors;
- Ø Diversification and standardization of IBA services.

<u>Area of Intervention 2</u> – Promoting the internationalization of the Bulgarian enterprises:

- Ø Providing more abundant and better quality information of foreign markets to Bulgarian enterprises;
- Ø Encouraging SME participation in international specialized fairs, exhibitions and trade missions;
- Ø Improvement of the image (branding) and the export potential of Bulgaria.

<u>Area of Intervention 3</u> – Improvement of the national quality infrastructure (NQI):

- Ø Information and awareness campaigns for businesses;
- Ø Upgrade of calibration and testing laboratories, conformity assessment bodies (CABs);
- Ø Offering more and better services to business.

Priority Axis 5 – Technical Assistance

<u>Area of Intervention 1</u> – Support for the management, implementation, monitoring and evaluation of the Operational program:

- Ocosts related to the preparation, selection, appraisal, monitoring and control;
- Ø Costs for meetings of the Monitoring Committee;
- Ø Audit expenses;
- Ø Costs for the provision of services relating to the preparation and implementation of an operation provided by a public authority.

Area of Intervention 2 – Other activities for the implementation of the OP:

- Ø Program management;
- **Ø** Staff training;
- Ø Preparation of researches for the needs of the OP;
- Ø Assistance to evaluation of projects;
- Ø Information campaigns and promotion activities.

- Ø Launch of call for projects proposals: 17 October, 2007;
- Ø Deadline for project proposals submission: 15 January, 2008;
- Ø Grant Budget: 5 mln. EUR.

Grant scheme "Upgrade of technologies in enterprises":

- Ø Priority Axis 2;
- **Ø** Launch of call for projects proposals: 17 October, 2007;
- Ø Deadline for project proposals submission: 22 January, 2008;
- Ø Grant budget: 25 mln. EUR.

Total Grant Budget: 38, 5 mln. EUR
